We have examined the financial records maintained by the Treasurer of the

for the period January 1, 1958 to September 30, 1958. The records had previously been audited by another Certified Public Accountant for the period from October 1, 1957 to December 31, 1957 and, in order to present a statement of operations for a complete fiscal year, we have combined the information presented in the statement of December 31, 1957 with information procured in our examination in preparing the attached statements.

#### SCOPE OF EXAMINATION

Our examination of the financial records included the tracing of all recorded receipts to deposits in the bank, the comparison of all cancelled checks with corresponding entries in the disbursement journal, and the reconciliation of cash on deposit at September 30, 1958. Available invoices and statements supporting disbursements were examined but we did not make a detailed audit of transactions. We did not confirm the amount of dues and receipts by direct communication with members.

Our examination was made on a cash receipts and disbursements basis and we are, therefore, not expressing an independent accountant's opinion on the overall representations in the attached statements.
