DR. GUY ODOM TO BE HONORED GUEST IN VANCOUVER

Guy Leary Odom was born in New Orleans in 1911. His father, a physician, died of influenza in 1918. Guy and his siblings were reared by their mother, and were maintained largely by their determination and ingenuity as a family. Dr. Odom completed undergraduate school in two full years and was graduated from Tulane Medical School in 1933 at the age of 21. During his years as a medical student, he developed an interest in the nervous system and decided that neurosurgery was a field to which he might contribute. After serving as an intern and resident at the East Louisiana State Hospital, Dr. Odom and his wife moved to Montreal for a neurosurgical residency at the Montreal Neurological Institute, 1937-42. His neurosurgical development was strongly influenced by Dr. Wilder Penfield who gave him a broad outlook on the neurological sciences, and by Dr. William V. Cone who taught him by example the importance of round-the-clock, nit-picking attention to the details of patient care and surgical technique. The Odom's returned to New Orleans in 1942 to start a neurosurgical practice. The following year, Dr. Odom accepted a position as Associate in Neurosurgery at the Duke University Medical Center, rising through the academic ranks to become Professor in 1950 and Chairman of the Division of Neurosurgery in 1960.

Dr. Odom's large bibliography bears witness to his productivity. Over the years, he has had a special interest in intracranial aneurysms, brain tumors, and the training of neurosurgical residents, but his main interest has always been the welfare of his patients. Dr. Odom loves the clinical practice in neurosurgery, devoting as much of his energy as possible to it. He enjoys sharing this consuming interest with others in his highly successful role as teacher and residency program director. An accomplished neuropathologist, Dr. Odom has also had some interest in experimental neurosurgery.

Judging by the number of times his advice is sought each day by his residents, his associates, and numerous neurosurgeons practicing in other areas, it is readily apparent that Guy Odom is a neurosurgeon's neurosurgeon. He is a physician in the Hippocratic tradition -- an intuitive human with a genuine concern for others and a zest for living.

# PROPOSED AMENDMENTS TO BYLAWS OF THE CONGRESS OF NEUROLOGICAL SURGEONS, INC.

To be voted on at the 1974 Annual Meeting, Vancouver, Sept. 26, 1974

#### PRESENT BYLAWS

#### PROPOSED AMENDMENT

#### Changes Needed to Remove Evidence of Sexual Discrimination From Bylaws

#### Article 1 - Section 4 - Sentence 1

The President, or in his absence, the Vice-President, shall preside at all meetings of the Congress and at all meetings of the Executive Committee. The President, or in the President's absence, the Vice-President, shall preside at all meetings of the Congress and at all meetings of the Executive Committee.

#### Article 1 - Section 5

The Secretary of the Congress shall keep the minutes of all meetings of the Congress and of the Executive Committee. He shall conduct the correspondence and keep the records and papers of the Congress. He shall give all notices required by the By-Laws, or by the orders of the Congress, or the President, or the Executive Committee and he shall perform such other duties as the Executive Committee may from time to time assign to him.

The Secretary of the Congress shall keep the minutes of all meetings of the Congress and of the Executive Committee, conduct the correspondence and keep the records and papers of the Congress, give all notices required by the bylaws, or by the orders of the Congress, or the President, or the Executive Committee and perform such other duties as assigned from time to time by the Executive Committee.

#### Article 1 - Section 6

The Treasurer shall collect the initiation fees and annual dues of all members and shall keep the accounts of the Congress and shall have custody of the funds of the Congress. He shall pay all bills of the Congress as authorized to do so by the Executive Committee. He shall make a report of the finances of the Congress at each annual meeting and when called upon by the Executive Committee. He shall arrange for an annual audit of the finances of the Congress by a Certified Public Accountant acceptable to the Executive Committee and this audit shall become a part of the Treasurer's annual report. He shall be Chairman of the Finance Committee.

The Treasurer shall collect the initiation fees and annual dues of all members, keep the accounts of the Congress, have custody of the funds of the Congress, pay all bills of the Congress as authorized to do so by the Executive Committee, make a report of the finances of the Congress at each annual meeting and when called upon by the Executive Committee, and arrange for an annual audit of the finances of the Congress by a Certified Public Accountant acceptable to the Executive Committee and this audit shall become a part of the Treasurer's annual report. The Treasurer shall be Chairman of the Finance Committee.

#### Article III - Section 3 - Paragraph A - Subparagraph 3

An outstanding record in the field of neurological surgery over a period of years, due to high standard and quality of his work.

Article III - Section 3 - Paragraph B Membership in good standing in his local or regional Medical Society except for officers in the armed forces.

#### Article III - Section 5 - Sentence 2

Any active member who is absent from three consecutive annual meetings may be suspended unless he has furnished the Secretary with a satisfactory written explanation.

#### Article III - Section 6 - Sentence 1

Each applicant for active membership shall file with the Secretary or Chairman of the Membership Committee such information as is necessary to determine his qualifications for membership.

#### Article V - Section 1

Before any person shall become a member of the Congress, he shall pay an initiation fee and the annual dues, provided he has been approved for membership by the Executive Committee and notified of his approval prior to September 1st of each year. If a member is elected subsequent to this time, then he shall not be required to pay the dues for that year.

#### Article VI - Section 1 - Paragraph A - Sentence 2

The immediate Past President shall be Chairman of the Nominating Committee and shall serve a second year following his year as Chairman.

An outstanding record in the field of neurological surgery over a period of years, due to high standard and quality of the applicant's work.

Membership in good standing in the applicant's local or regional Medical Society except for officers in the armed forces.

Any active member who is absent from three consecutive annual meetings may be suspended unless that member has furnished the Secretary with a satisfactory written explanation.

Each applicant for active membership shall file with the Secretary or Chairman of the Membership Committee such information as is necessary to determine said applicant's qualification.

Before any applicant shall become a member of the Congress, said applicant shall pay an initiation fee and the annual dues, provided the application has been approved by the Executive Committee and that said applicant has been notified of the Executive Committee's approval prior to September 1st of each year. If a member is elected subsequent to this time, a dues payment for that year shall not be required.

The immediate Past President shall be Chairman of the Nominating Committee and shall serve a second year following the year's tenure as Chairman.

## Article VI - Section 1 - Paragraph N - Sentence 2

He shall prepare not less than four editions annually.

## Article VII (last paragraph) - Sentence l

Each representative shall file a report of the activities of his committee or organization with the Secretary of the Congress within 30 days following a meeting of that organization or committee.

#### Article VIII - Section 1 - Sentence 1

An Auxiliary shall be established composed of wives of the members of the Congress.

The editor shall prepare not less than four editions annually.

Each representative, delegate, or member shall file a report of the activities of the specific committee or organization with the Secretary of the Congress within 30 days following a meeting of that organization or committee.

An Auxiliary shall be established composed of spouses of the members of the Congress.

#### Committees and Representatives

#### Article VI - Section K

International Board. Shall consist of the General Chairman. Chairman of the World Directory, Representative to the Care-Medico Advisory Board, the two Delegates to the World Federation of Neurosurgical Societies. the Chairman of the International Service, Education and Training Committee, Chairman of the International Program Committee, and such members at large as may be deemed advisable. This board shall direct its interest toward all international aspects of the Congress and shall encourage and promote the international interests and activities of the Congress.

#### Article VI - Section M

Long Range Planning Committee. Shall consist of a Chairman and four members who shall meet at least annually to discuss and make recommendations relative to long range plans and policies of the Congress.

Shall consist of a Chairman, a representative to the Care-Medico Advisory Board, two Delegates to the World Federation of Neurosurgical Societies and Chairman of the World Directory and such members at large as may be deemed advisable. In addition to monitoring overseas neurosurgical trends and needs which may be of relevance and importance to the members of the Congress, the Board will sponsor an annual international meeting or seminar to occur during the annual meeting.

REASON: To make bylaws comply with current practice.

Shall consist of the President-Elect, as Chairman, Past-President, Vice-President, Secretary, Treasurer, and two other members appointed by the President who shall meet at least annually to make

recommendations relative to long range plans and policies of the Congress.

REASON: To make bylaws comply with current practice.

#### Article VI - Section 0

Sabbatical Interchange Registry shall consist of a Chairman and five
or more members who shall plan and develop
a registry to provide information relative
to persons on sabbatical leave seeking
locations for continued study and neurosurgeons and or institutions who have
special interest areas suitable for continued study by other neurosurgeons.

#### Delete

REASON: By Executive Committee action, the concept of a sabbatical interchange registry was abandoned on 10-5-73.

#### Article VI - Section R

Socio-Economic Committee. Shall be composed of a Chairman and approximately six members who shall have the responsibility for reviewing, investigating, and advising relative to all matters of a socio-economic nature pertaining to the field of neurological surgery.

Shall be composed of a Chairman and at least six members who will form a joint socio-economic committee with the American Association of Neurological Surgeons. The joint committee shall be called the Joint Socio-Economics Committee of the American Association of Neurological Surgeons and the Congress of Neurological Surgeons. The Joint Socio-Economics Committee shall have the responsibility of reviewing, investigating, and advising relative to all matters of a socio-economic nature pertaining to the field of neurological surgery.

#### PRESENT BYLAWS

Article VI - Section G

The Chairman of this committee shall serve three years; and shall serve on the annual meeting committee.

#### Clinical Neurosurgery Committee.

REASON: This Committee has previously worked as an ad hoc committee appointed by the President. There is a need for continued review of materials and devices used in neurological surgery.

SURGICAL NEUROLOGY Committee.
Shall consist of a chairman and at least three members who shall be responsible for reviewing the Congress' collaborative arrangement with the editor of SURGICAL NEUROLOGY and set policy as related to perpetuation of this Journal by the Congress of Neurological Surgeons.

REASON: There is a need for a committee to coordinate and review the Congress of Neurological Surgeons' collaborative agreement with SURGICAL NEUROLOGY. Article VII - Representatives - Section N


