RESIDENT MEMBER HOUSING GUIDELINES 2019 CNS Annual Meeting – October 19 – 23, 2019

- The subsidized housing benefit is available beginning with arrival Friday, October 18, 2019 and departure, Wednesday, October 23, 2019. To be granted a Friday or Saturday night hotel stay you must also be registered for a CNS Symposia the following day. Housing is confirmed on a first come, first-served basis as long as the CNS subsidized housing is available. Double Occupancy applicants will be given priority over requests for single occupancy, regardless of application date.
- Eligibility is open to CNS Resident Members (US/Canada/Mexico) and International Vista Resident Members (outside North America) in good standing and only at the San Francisco Marriott Marquis or Westin St. Francis. This benefit does not apply to residency graduates who are participating in a fellowship in Neurosurgery. Residents in ACGME accredited programs are automatically granted complimentary CNS membership at the commencement of their programs. Canadian and Mexican neurosurgical residents may become CNS Resident Members by completing a Resident application and submitting their one-time \$25 application fee. International neurosurgical residents may become CNS International Vista Resident Members by completing the IVR application and submitting a dues payment of \$50 by July 26, 2019. - To apply for Resident Housing, complete the Resident Member Housing Application. All applications must be sent directly to the CNS, not the hotel or the CNS Registration and Housing Center. You may submit your completed application via the following:

- The CNS Resident member housing is based on double occupancy. You will be matched with a roommate of the same gender. Each prospective applicant must sign the application indicating that they agree to the assignment of a roommate by the CNS to receive subsidized housing at the 2019 CNS Annual Meeting. The CNS shall not be held liable for any matters arising from, related to, or in any way connected with the Annual Meeting, including roommate assignments made by the CNS.
- If you would like to request a specific Resident as your roommate, both applications must be submitted together. Both applications must be signed by both residents indicating mutual agreement to share a room with each other. If your occupancy dates do not match, you will be charged the single rate of \$115.13 for unmatched nights. Resident housing is available at the San Francisco Marriott Marquis and the Westin St. Francis.
- Shared resident accommodations will have priority over requests for single occupancy accommodations. Requests for single occupancy or with a spouse will be eligible for a partial CNS subsidy. The CNS will cover a portion of the room rate and the resident is responsible for paying the additional portion of the room rate directly to the hotel.
- CNS subsidizes room rate and tax only. Residents are responsible for all other hotel expenses incurred during their stay (i.e., room service, mini bar, telephone calls, etc.) and will be required to present a credit card at check in.
- To be considered for this program, participants must be registered for the 2019 CNS Annual Meeting AND submit their Resident Housing Application no later than Friday, August 9, 2019. If you are not registered for the meeting, you will not be eligible for resident housing.
- If you are accepted for the CNS Resident Housing Program, you will be notified if you are accepted and what hotel you are assigned to no later than Friday, August 16, 2019. You will receive an emailed confirmation of your acceptance and you must reconfirm your participation, including arrival and departure dates by the deadline on that confirmation. If you are accepted and have also reserved a room through the CNS Registration and Housing Center, it is your responsibility to cancel your extra room and request a refund of your housing deposit.
- Please note: If you decide not to attend or change your arrival date, it is your responsibility to contact the CNS directly. Any expenses incurred due to cancellation, no show or late arrival will be billed to you.
