Robert Weyard reports these details in arranging to get loan slides from the Army Institute -- Thanks, Bob, for the information.

"The Armed Forces Institute of Pathology has sets of histopathological slides, accompanied by a list of diagnoses, and a syllabus which are available by loan. The loan period is for two weeks only and the borrower must pay for the expense of shipping the slides. There is one set entitled 'Large Neuropathology' which contains 85 slides, one set entitled 'Small Neuropathology' which contains 50 slides, one set entitled 'Brain Tumors' which contains 50 slides, and one set entitled 'The Encephalitides' which contains 25 slides. In order for a physician to request the loan of these slides it is necessary for him to submit a specific form to the Institute. These forms can be obtained by writing to the Director, Armed Forces Institute of Pathology, 7th Street & Independence Avenue, SW, Washington 25. D. C.; the address should be marked 'Attention: American Registry of Pathology'."
