Re: Reopening the reporting Period 1 for Provider Relief Fund

Dear Administrator Johnson:

On behalf of our members, the American Medical Association (AMA) and the undersigned national medical specialty societies urge the Health Resources and Services Administration (HRSA) to reopen Reporting Period for at least 60 days to applicable Provider Relief Fund¹ (PRF) recipients who did not report through the HRSA PRF Reporting Portal by the November 30, 2021, deadline. A number of physician practices have reached out to us with their serious concerns about the Period 1 funding they received being recouped and have provided greater insight into the many reasons why reporting by the deadline did not occur. We offer greater insight into the challenges the physician practices face which have impeded their ability to comply with the deadline, but moreover, offer our assistance to work with HRSA in an effort to reach those who have yet to report.

Small and rural physician practices appear to be particularly impacted by the reporting deadline and the potential recoupment of funds. These practices, often under-resourced even while they provide critical health care services, cannot afford to have the funds they received recouped. During the late fall when the Delta variant was surging, these physician practices and others were greatly impacted by the COVID-19 surges in many ways that may have prevented or delayed the required reporting:

- Practices reported they were not contacted about the requirement to report and were thus unaware of the deadline;
- Medical and administrative staff contracted COVID-19 or were acting as a caregiver and, therefore, were out of off the office which caused them to miss the reporting deadline; and
- Staffing challenges and turnover resulted in the practice's point of contact no longer being affiliated with the practice.

We are hearing that the practices out of compliance simply did not know about the requirement to report. It is possible that the emails that HRSA sent did not reach a number of the recipients and a broader communications strategy will be needed to connect with physician practices. As we are very connected to our members, we would like to work with HRSA on best ways to identify and reach the remaining practices that have not reported to bring them into compliance. We ask that HRSA reopen the Period 1 reporting window for at least 60 days and engage in a targeted campaign to reach those who have yet to comply.
